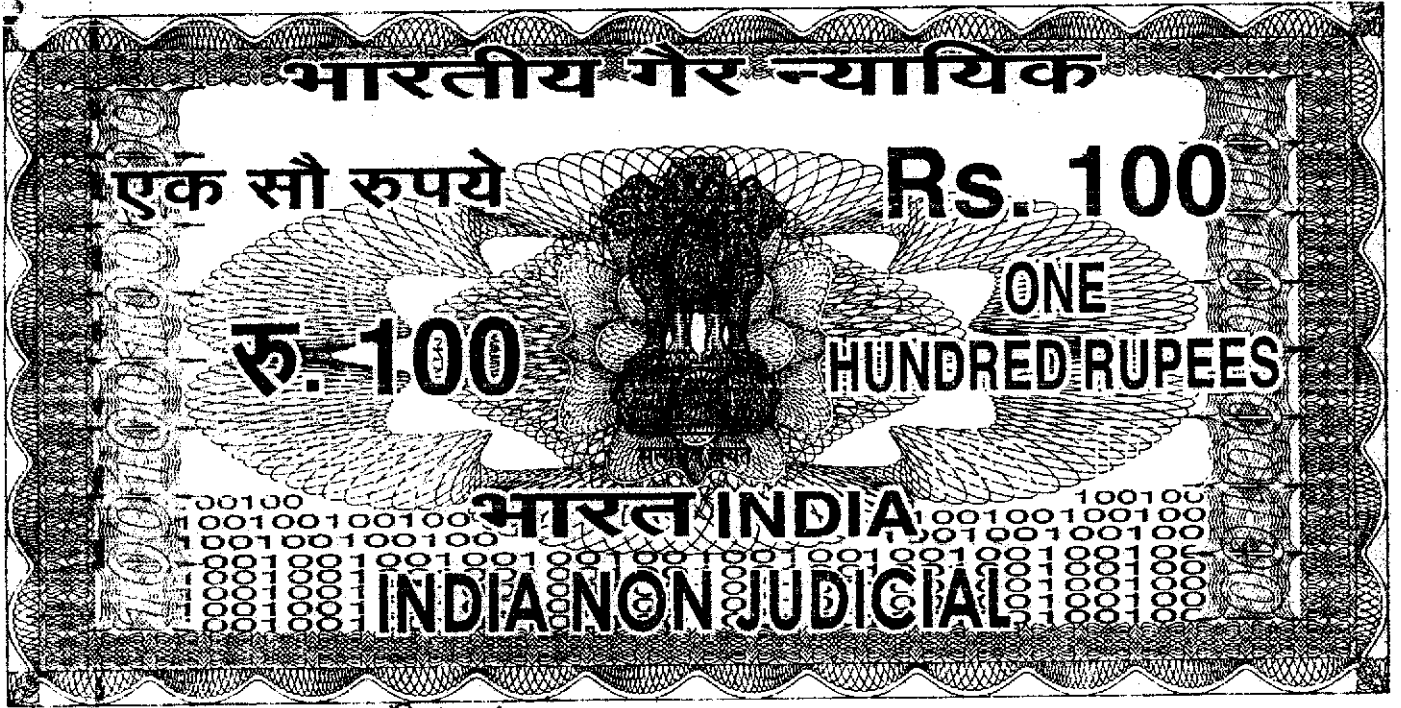

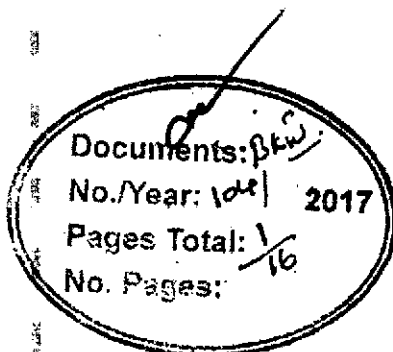
TRUST DEED OF A PUBLIC CHARITABLE TRUST

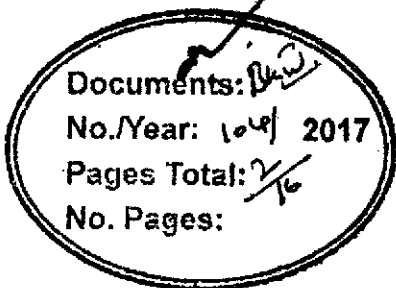

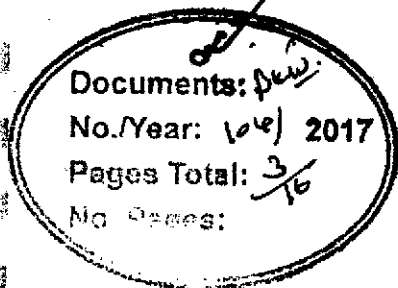
1. NAME:

3.OBJECTS OF THE TRUST:

A. To open, establish, construct, maintain, run, develop, improve and extend and aid in the opening, establishment, construction, maintenance, running, development, improvement and extension of;

- i. Schools, Colleges and other institutions for the study of science, medicine, engineering art, history, humanities, commerce, finance, economics, law, music, dancing, painting, sculpture, astronomy, architecture, different languages and literature and other educational subjects.
- ii. Schools, Colleges and Vocational Training Centres.

- iv. Hostels and Orphanages and other homes for poor and orphaned pupils, whether studying in schools, colleges or other institutions.
- v. Public libraries both for the benefit of the students and for the public.

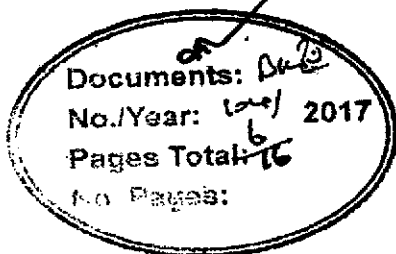
- vi. To establish, run, manage, administer any institutions or college or school to train persons to be teachers who will impart education to children and/or students in School, Colleges and other similar institutions.
- vii. To promote Adult Education.
- viii. To hold arrange and organize meetings, lectures, talks, discussion, seminars, symposia, conferences, competitions, research and study visits, tours, excursions, exhibitions, debates, cinema, audio visual programmes, the artistic performances and other cultural activities, sports and game.
- ix. Advancement of any other object of general public utility and relief like conducting seminars on educational advancement, providing necessary assistance during natural calamities and such other assistance as may be required from time to time.

B.. To aid by donations and contributions to other public charitable trust or institutions having similar object of this trust.

4. TRUST BOARD:

- i. The Trust Board shall consist of Minimum Two Trustees and Maximum of Ten Trustees including Life Trustees.
- ii. **Smt. Prema Anand Rao, (Aadhar No: 3892 5050 1684), W/o Sri G Anand Rao and Sri G Anand Rao (Aadhar No:9782 1677 5720), S/o Sri Govinda Rao** shall be the Life Trustees.
- iii. The Life Trustees may co-opt one or more Trustees and shall determine the term of office of Trustees.
- iv. The Life Trustee shall have power to remove the co-opted Trustees without assigning any reason.
- v. In the event of the Life Trustee vacating the office for whatsoever reason the remaining Life Trustee can nominate a person to be a Life Trustee.
- vi. The Lift Trustees shall elect one among themselves as a Managing Trustee. In the event of resignation or death of the Managing Trustee the vacancy shall be filled by the Life Trustees from among any of them.
- vii. The Managing Life Trustee shall administer and manage the Trust and exercise all the powers of the Trust Board as may be delegated.

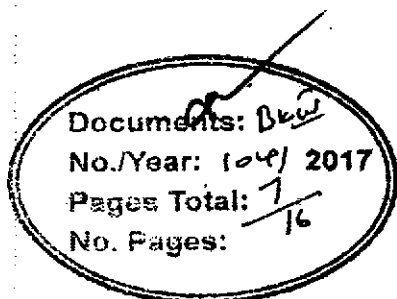
- viii. Trustees shall not be personally liable for any action bone fide undertaken in exercise of their powers and duties as trustee and they shall stand indemnified for any loss or damages to which they may be subject to in such exercise.
- ix. The Trustees shall have power to frame from time to time Rules for the proper conduct of the affairs of the Trust and alter, amend any of the powers vested in them for administration of the Trust herein. Any amendment to the object clause of the Trust Deed shall be carried out only with the approval of the Commissioner of Income Tax.
- x. No trustee shall be responsible or liable for any loss or any act of omission or commission by his constituted attorney or agent or employees or other trustees unless occasioned by his willful neglect or default.

5. FUNDS

The Trustees may accept donations, grants, subscriptions, aids or contributions from any person, Government, Local authorities or any other charitable institutions, in cash or in kind including immovable property without any incumbrance, but the Trustees shall not accept any receipt with any condition or terms inconsistent with the objects of the Trusts. While applying such receipts to the objects, the Trustees shall respect the directions, if any, by the granter. Any receipt with specific direction to treat the same as part of the corpus of the Trust or separate fund shall be funded accordingly.

6. INVESTMENTS

- I. All monies, which shall not immediately required for current needs shall be invested by the Trustees in eligible securities and investments, or in banks. Such investments shall be in the name of Trust or Trustees.
- II. That the trustees shall invest the trust fund, carry on any business with the trust fund and/or enter into partnership on behalf of the trust, as they may deem fit.
- III. That the trustees shall manage the trust fund and investments thereof as a prudent man would do the same. They shall recover all outstanding's and meet all recurring and other expenses incurred in the upkeep or management thereof.

- IV. That the trustees shall receive and hold the income of the trust on behalf and for the benefit of the beneficiaries under the trust.
- V. The above such investments shall be in accordance with the provision of Section 13(I) read with Section 11(5) of the Income Tax Act, 1961 as well as of any other law for the time being in force as are applicable to charitable trusts.

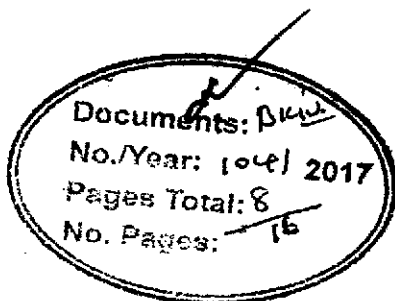
7. POWER OF TRUSTEES

That the Managing Trustees shall have the following powers :

- I. To manage all the assets and/or properties of the trust
- II. To purchase/sale of any moveable/immovable properties such as land, building, license, stores, materials, machineries, equipment's and any other incidental property or goods as may be necessary from time to time.
- III. To pay all charges, impositions and other outgoings payable in respect of the trust properties and also to pay all cost of the incidental to the administration and management of the trust properties;
- IV. To borrow money from any person with or without security as the trustees may think fit and to pledge or mortgage the properties of the trust for this purpose.
- V. To let-out properties of the trust in any manner.
- VI. To enter into any contract/agreement/deeds for the purpose of facilitating the objectives of the trust with any person or any regulating authorities.
- VII. To appoint or remove Secretary / professionals / employees / trainees and to settle the terms of their service, remuneration and termination;
- VIII. To look into the management of the trust;
- IX. To invest the funds of the trust, in bank or in the purchase of company shares or securities or other movable and immovable properties subject to the provisions of the Income Tax Act for availing exemption thereon;
- X. To open and close accounts with Banks, to operate upon any such accounts, to pay and draw money from such accounts and otherwise deal with the names and the powers in this behalf may be exercised by the Managing Trustee or by any other Trustees empowered by a resolution of the Board of Trustees in a meeting.

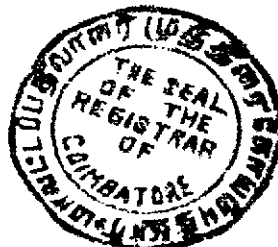
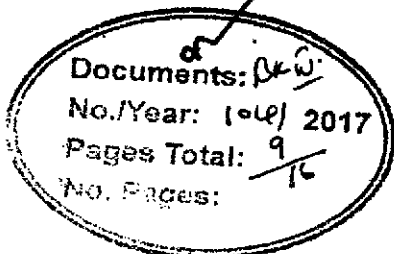
- XI. To enter into a partnership on behalf of the trust with any other party or parties;
- XII. To arrange/conduct/execute any legal proceedings/dispute/claim, by or against the trust.
- XIII. To accept any gift, donation or contribution in cash or in kind from any person.
- XIV. To draw, make, accept, endorse, discount, negotiate, execute and issue promissory notes, bills of exchange, hundies, cheques, Government and other securities and other negotiable instruments.
- XV. To seek legal opinion of lawyers and/or Chartered Accountants as and when required;
- XVI. To insure and keep insured, if deemed expedient all or any of the buildings and other assets of the Trust;
- XVII. to nominate or appoint attorneys or agents and to delegate all or any of the duties and powers vested in him/her to such attorney or agent, and to remove such attorney or agent and reappoint other or others in his place.
- XVIII. The Managing Trustees shall have power to frame from time to time Rules for the proper conduct of the affairs of the Trust and alter, amend any of the powers vested in them for administration of the Trust herein. Any amendment to the object clause of the Trust Deed shall be carried out only with the approval of the Commissioner of Income Tax.

8. PROPERTIES OF THE TRUST:

- I. The Trust properties shall comprise of all funds received as donations whether as corpus fund or otherwise, all income, the investments, movable and immovable properties acquired by gift, purchase, lease or otherwise and all the properties shall be held either in the name of the Trust or in the names of two of the Life Trustees as the circumstances may require.
- II. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly.

9. BANKING ACCOUNT :

All income, subscription and pecuniary donations for the general purposes of the Trust and the income, investments and all other moneys from time to time forming part of the general revenue of the Trust shall on the same being received be paid into a banking account with any scheduled bank for the purpose of the Trust. The bank accounts shall be operated by the Managing Trustees.

10. ACCOUNTS AND AUDIT:

- I. The Trustee shall keep proper books of account of all the assets, liabilities and income and expenditure of the Trust and shall prepare an Income and Expenditure Account and Balance Sheet for every year as on the last day of March.
- II. The accounts of every year shall be audited by a Chartered Accountant or a firm of Chartered Accountants who shall be appointed for that purpose by the Trustees and the audited accounts shall be placed at a meeting of the Trustees, which shall be held before the end of the succeeding year.

11. EXECUTION OF DOCUMENTS :

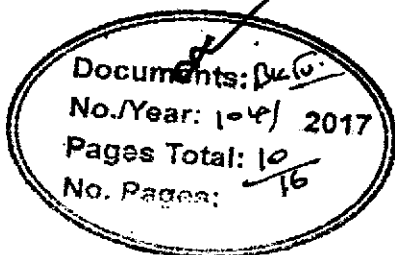
All agreements/deeds/documents/contract etc. shall be executed by Managing Trustee of the Trust.

12. MEETINGS:

- I. The Managing Trustee shall preside over all the meetings of the trustees and in his/her absence, the trustees attending such meetings may elect any one of them to preside over the meeting;
- II. The meetings of the Trustees may be convened by the Managing Trustee or any other trustee directed by the Managing Trustee.
- III. The quorum of the meeting of the Trustees shall be more than half of the total trustees.
- IV. In the event of equality of votes, the person presiding over such meeting shall exercise casting vote (casting vote).

14. ACTIVITY OF THE TRUST:


- I. The activities of the Trust shall be confined to the territorial boundaries of India.
- II. The trustees will take every effort to comply with the provisions of the Foreign Contribution Regulation Act, 2010 ('FCRA') as well as the Foreign Exchange Management Act, 1999 ('FEMA') in case any donation is received from abroad or from foreign nationals.
- III. The Trust shall not carry on any activity with the intent of earning profit.
- IV. The benefits of the Trust are open to all irrespective of nationality, religion, caste, creed, sex etc.,

15. DISSOLUTION OR WINDING UP:

In the event of dissolution or winding up of the Trust the assets remaining as on the date of dissolution shall under no circumstances be distributed amongst the Trustees but the same shall be transferred to some other similar Trust/Organization whose objects are similar to those of this Trust.



